

**INFORMATION NOTICE PROVIDED TO CUSTOMERS PURSUANT TO ARTICLE 13 OF EUROPEAN REGULATION NO.  
2016/679**

This information notice is provided by the sole shareholder company Tecnoinox s.r.l. to its customers to provide the same with information regarding the processing of their personal data carried out by Tecnoinox s.r.l..

The **Data Controller** is Tecnoinox s.r.l., sole shareholder, VAT reg. no. IT01039240930, with registered office in Via Torricelli 1, Porcia 33080 (PN). **Purpose of the data processing.** Your personal data is processed for the following purposes:

1. Establishment and performance of the contractual relationship with the customer and related activities, including administrative and accounting activities;
2. Compliance with legal obligations;
3. Credit recovery and judicial protection and related activities;
4. Credit assessment and insurance;
5. Direct marketing (sending newsletters and promotional material).

**Legal basis.** The processing is carried out legitimately based on the following conditions:

1. Performance of the agreement for purpose no. 1;
2. Legal obligation for purpose no. 2;
3. Legitimate interest for purposes no. 3 - 4 - 5.

The provision of personal data is mandatory for performance of the agreement and any failure to provide said data or any partial or incorrect provision of the same may prevent any such performance or render it inaccurate.

**Recipients.** The customer's personal data may be communicated, for the purposes described, to the following categories of recipients: agents, partners (retailers and/or service centres), professionals (accountants, law firms, consultants), business information companies, supervisory bodies and judicial authorities, information technology service companies, transport and logistics companies, credit institutions and insurance companies, and communications agencies.

**Duration of the data processing.** The data will be processed for the duration of contractual relationship and the data will be retained for a maximum period of 10 years in order to fulfil legal obligations and guarantee the legitimate interests of the Data Controller. The data will be processed for marketing purposes for a period of 24 months commencing from when the business contact is made or when the business relationship is established.

**Rights.** Data subjects have the right to request from the Data Controller access to personal data concerning them, erasure of their personal data, rectification of any inaccurate data, to have incomplete data completed, restriction of processing, data portability, to object to processing where it is considered to be in the legitimate interest of the Data Controller, to withdraw their consent where processing is based on said consent and for marketing purposes, in the cases and in accordance with the conditions set out in the relevant articles of Regulation no. 2016/679. Data subjects also have the right to lodge a complaint with the competent supervisory authority in the Member State in which they have their habitual residence or place of work or in the Member State in which the alleged infringement took place.
